DESCRIPTION

This half-day, 5-hour virtual conference acknowledges and seeks to address the increased incidence of mental health challenges in Bermuda.

The goal with this symposium is to examine mental health conditions throughout the lifespan, along with more specific mental health concerns related to gender. This approach will improve support in engaging clients whilst implementing and understanding the Recovery model and seeking to improve patient outcomes

OBJECTIVES

- Recognise various mental health diagnoses throughout different stages of life and how they may manifest, and the recommended treatments associated with each.
- Identify gender-specific mental health disorders and diagnoses, along with more tailored treatments.
- Explain the Recovery model in practice, while emphasizing its role within the Bermuda community and beyond.
